As we are all aware of, the COVID-19 pandemic demands that we change the way we work, interact and communicate. The pandemic has also changed the way the underprivileged customers do their business and lead their daily lives. This has resulted in millions of customers having to try and change their strategies and struggle for their business survival and recovery.

This was when the role of #bankirpemberdaya being truly tested, namely how to facilitate ease and convenience to financing customers who were afflicted.
